

**St. Luke University Parish
House Raffle Official Rules and Regulations**

ST. LUKE UNIVERSITY PARISH, a tax exempt organization under Section 501(c)(3) of the Internal Revenue Code, is conducting a raffle in accordance with Michigan Charitable Gaming Rules R 432.21101(1)(f). ST. LUKE UNIVERSITY PARISH is registered with the Michigan Charitable Gaming Division, Registration #C25232.

The Rules and Regulations of the raffle are set forth below, and all raffle ticket holders agree to be bound by these rules and regulations. ST. LUKE UNIVERSITY PARISH'S interpretation and application of these rules and regulations shall be final.

The drawing for this raffle will be held on December 31, 2011 at approximately 11:00 pm at Main Street Pub in Allendale with an early bird drawing Sept 10, 2011. Tickets will be sold up until 7 pm Eastern Standard Time, December 31, 2011. Grand prize will be a 2012 FORD MUSTANG CONVERTIBLE or other automobile from Borgman Ford up to \$30,000, or \$20,000 in cash. 2nd, 3rd, 4th, 5th, 6th prizes be \$1000, \$500, \$250, \$100, \$50 respectively. The winner will be randomly selected in a drawing from among all eligible entries. If fewer than 2,500 tickets are sold, the raffle will be held as scheduled and the prize will be awarded by ST. LUKE UNIVERSITY PARISH with the exception that the Grand Prize winner will receive a sum equal to 50% of the net raffle proceeds. No other prizes will be awarded. The Early bird prize will be \$500. The drawing for prizes is open to the public, and the winner need not be present to win the top three prizes.

Raffle tickets are \$25 per ticket with all denominations in US Dollars. No additional purchase or contribution is necessary. ST. LUKE UNIVERSITY PARISH reserves the right to disqualify any ticket purchased with payment that does not constitute "good funds". Examples of grounds for disqualification include, and are not limited to, payment by a check that is returned due to insufficient funds, non-approval of a credit card payment, etc. ST. LUKE UNIVERSITY PARISH assumes no responsibility for lost, late, misdirected or non-delivered mail, fax messages, email messages or any other failure to sell tickets prior to the applicable raffle deadlines established herein.

Selection of Winner:

The ST. LUKE UNIVERSITY PARISH raffle drawing will be held on December 31, 2011, from all eligible raffle tickets with the winner selected by random draw. The Grand Prize winner is the person whose name appears on the first ticket stub drawn. The other prizes will be drawn subsequently. The winners will be notified according to the contact information provided to ST. LUKE UNIVERSITY PARISH at the time the ticket was purchased. If any potential winner cannot be reached after a reasonable effort has been exerted, if he/she is found to be ineligible, if he/she cannot or does not comply with these Official Rules, or if his/her prize or prize notification is returned as undeliverable, such potential winner will be disqualified at sole discretion of St. Luke University Parish. If the prize winner cannot be located at the time of the drawing, or after St. Luke University Parish has made a reasonable effort to make contact, or should the prize winner not claim their prize within thirty (30) days of the prize drawing date, the prize will be assumed a donation to St. Luke University Parish. In addition to efforts to make direct contact as above described, the name of the winner will be posted to and publicly available on the official raffle website at www.lukespot.com/raffle.

Eligibility:

Anyone 18 years of age or older at the time of purchasing a raffle ticket may enter. ST. LUKE UNIVERSITY PARISH employees, Parish Leadership, its authorized agents, consultants, attorneys, and their immediate family members living in the same household are able to participate and are eligible to win. All federal, state, and local laws and regulations apply. The Raffle is void where prohibited or restricted by law.
